








The Project Timeline



What is the ADA?

The ADA is a **civil rights law** that prohibits discrimination on the basis of disability.

The ADA ensures equal opportunity in:

- Employment
- Government services
- Public accommodations
- Telecommunications



ADA Title II Requirements

- 1. Designate Responsible Employee
 - ADA Coordinator
- 2. Establish Grievance Procedure
- 3. Provide Notice to the Public
- 4. Conduct a Self-Evaluation
- 5. Develop a Transition Plan



Scope of Project

ADA Transition Plan

- 1. Self-assessment to identify barriers
 - Parks and Facilities
 - Public Right-of-Way (ROW)
 - Programs, Services, and Activities
- 2. Provide methods to remove barriers
- 3. Schedule to achieve "Program Access"
- 4. Name a person responsible
- 5. Public engagement

Scope Components

- 1. Department interviews
- 2. Public Input
- 3. Analyze City Programs, Services, and Activities (PSAs)
 - Review Policies & Procedures
- 4. Assessments of City parks, facilities, and ROW
 - Develop dataset and GIS integration
- 5. ROW Programmatic Approach
- 6. Provide City staff training
- 7. Update ADA Transition Plan



Vision for the City of Evanston

- 1. Meets ADA Title II Requirements
- 2. Enhances existing PSAs
 - Staff training to improve delivery of PSAs
 - City has tools to review all future PSAs
- 3. Creates accessibility, inclusion, and equity
- 4. Benefit to the residents of Evanston
 - Creates a more accessible community
 - Creates a more inclusive community







Public Input Plan

- 1. Two Community Meetings
 - Open House #1 was held on November 18, 2021, at the Levy Senior Center
 - Open House #2 is today!
- 2. Online Survey and Input
 - Open November 18 December 19, 2021
 - Provided in English and Spanish
 - Generated 165 responses
 - Provided infrastructure priorities
 - Provided programs, services, and activities priorities

3. ADA Advisory Group input

- Volunteer advisory group made up of members of and advocates for people with disabilities
 - 1. Met on August 5, 2021 and July 27, 2022


