(I) CALL TO ORDER/DECLARATION OF QUORUM

Chair Nieuwsma called the meeting to order at approximately 7:15 pm

(III) PUBLIC COMMENT

- Fred Tanenbaum inquired about the redistricting process.
- Steve Miskowicz, president of the Sherman Plaza condo association, stated that he prefers that block to remain in Ward 1.
- Tina Paden had a question about the block bounded by Emerson/Foster/Sherman/Purple Line
- Clare Kelly expressed a desire to keep Sherman Plaza block in Ward 1.
- Carl Klein offered several other options for more compact maps (see attached "Proposed Map Option B" and "Proposed Map Option C"), stated that downtown Evanston should be in only one ward, and stated that communities and demographics should be taken into account.

A. Discussion of proposed map(s)

- A single map was presented for discussion: “Proposed Redistricting Plans March 28, 2023 Option A.” Councilmember Wynne explained that this map was created by combining earlier drafts that she and Councilmember Nieuwsma had created.
- After discussion, Councilmembers Wynne & Burns moved/seconded recommending the single proposed map for an additional round of public comment and for presentation to the City Council for discussion at the April 10, 2023 Council meeting.

B. Discussion of process moving forward

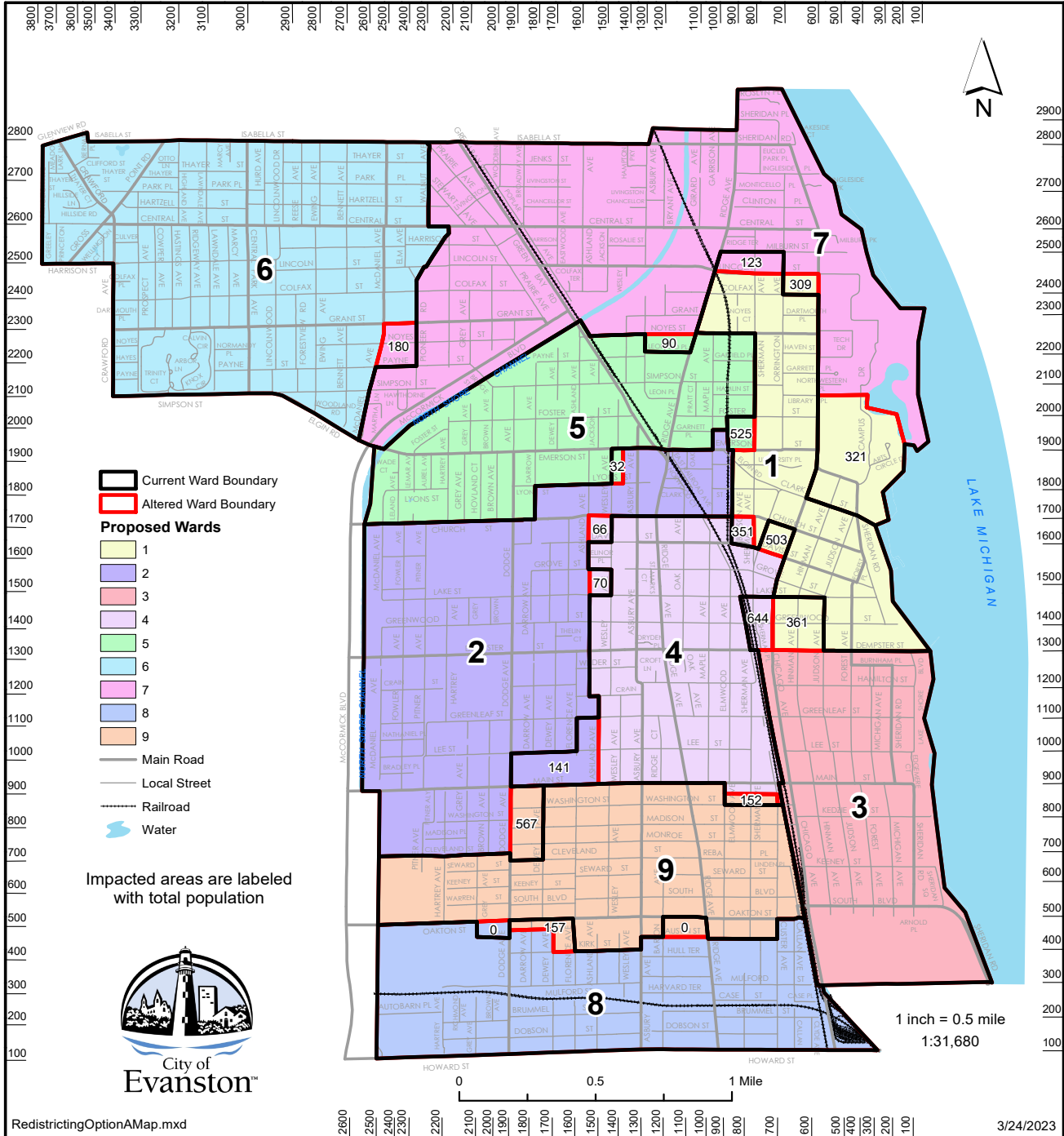
- Staff will prepare an online feedback form and make an announcement via regular e-newsletter.

Proposed Redistricting Plans March 28, 2023

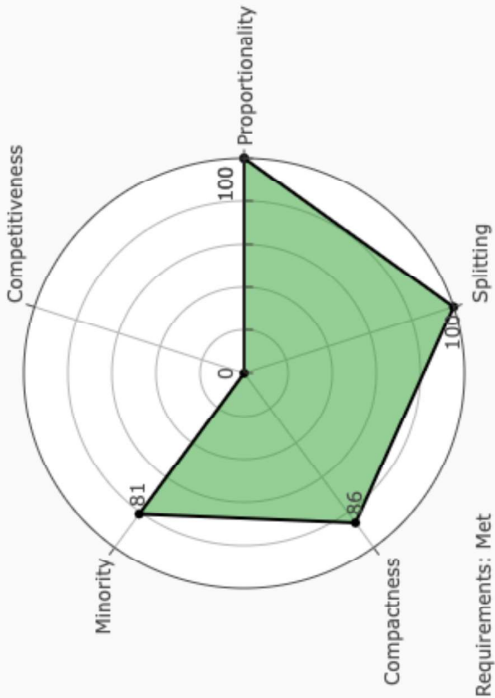
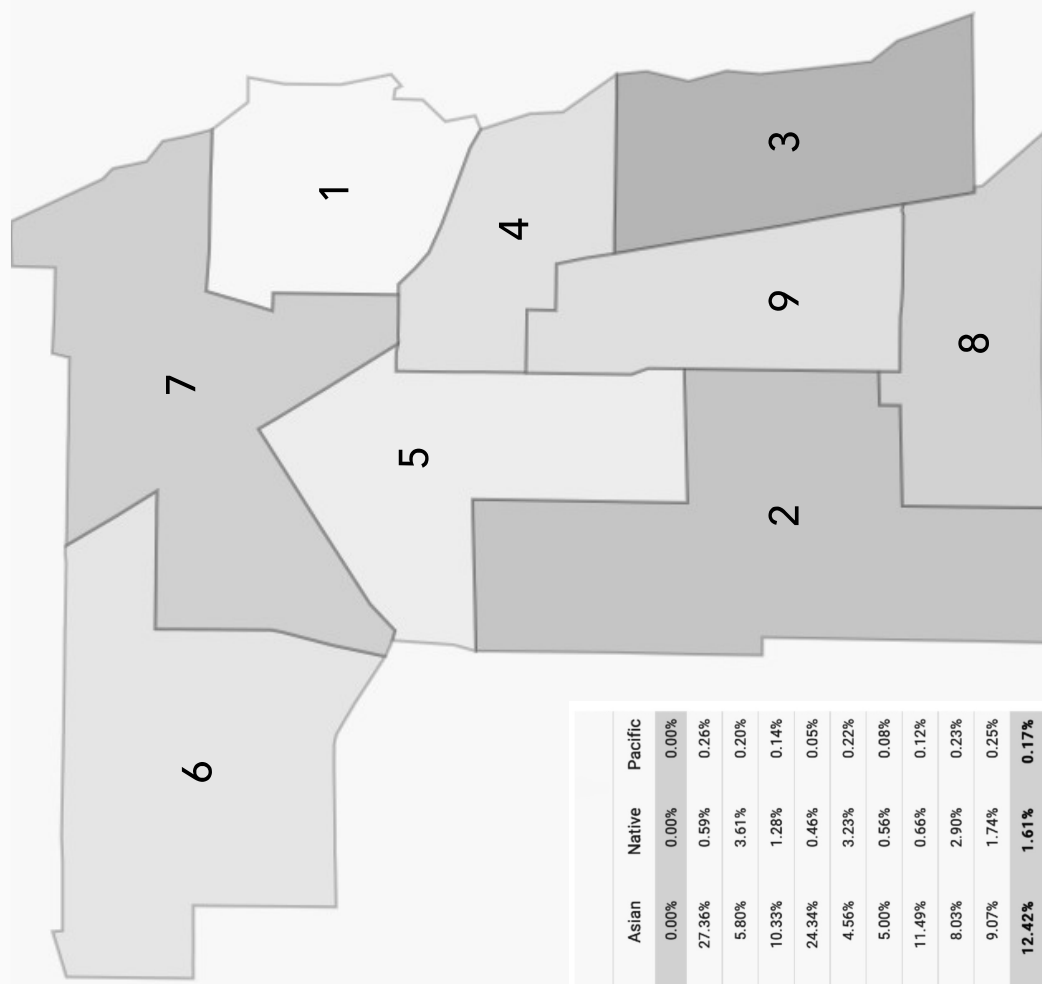

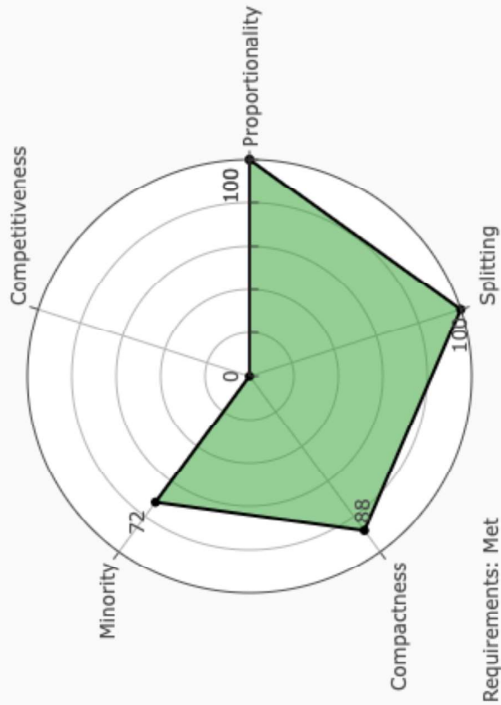
