

<u>CITY OF EVANSTON</u> RETAIL SINGLE USE BAG TAX

- 1. <u>FEE LEVIED:</u> A fee is levied on the sale of single use bags in City of Evanston at retail at a rate of \$0.10 cents per bag pursuant to Ordinance 1-O-23. A qualifying retail establishment may retain an amount of money equal to \$0.05 cents per single bag of the total fee due as compensation for the collection of the fee and the remaining \$0.05 cents shall be remitted it to the Village.
- 2. <u>LIABILITY FOR PAYMENT</u>: A qualifying retail establishment's customer must pay the \$0.10 cents fee to purchase a single use bag. B. The fee shall be paid in addition to any and all other taxes and charges for the purchase of a single-use bag.
- 3. <u>FILING OF RETURN</u>: A qualifying retail establishment within Evanston must file a report of all transactions subject to the fee on or before the 20th day of each month. At the time of filing, the owner or operator shall pay to the City of Evanston all fees due for the period to which the fee return applies.
- 4. <u>PENALTY</u>: Any qualifying retail establishment that fails to pay the fee or file a return in violation of the Village Code is subject to a fine of not less than \$100.00. Each day a violation occurs shall constitute a separate and distinct offense.
- 5. <u>SUSPENSION OR REVOCATION OF A BUSINESS LICENSE</u>: In addition to the penalty set forth above, the City Manager or their designee may revoke or suspend a qualifying retail establishment's business license if it is determined the qualifying retail establishment has failed to comply with the duties imposed under the above sections after notice. The suspension or revocation of a license shall not release or discharge the qualifying retail establishment from its liability to pay the fee or from any other penalties authorized by this section.
