Dear Mayor Biss and Council Members,

I am Kathy Lifton and live in Southeast Wilmette.

The Northwestern design has the stage for the proposed outdoor mega rock concerts facing Northwest. According to the Arup sound study, 70 decibels of sound will project into Wilmette as far north as Maple Park.

This will include sound from the 4 - 7 days of sound system setup as well as concert day. Let's assume an average of 5 days setup and one concert day for a total of 6 days per concert. Six concerts times 6 days equals 36 days of sound reaching 70 decibels for residents of Wilmette. The noise pollution is not just the duration of the 2 or 3 hour concert.

If the proposed concerts are approved, and, given three months of summer, Wilmette residents will be subjected to sound reaching 70 decibels for over a third of the summer.

Wilmette does not get to vote on the proposed concerts, nor does it receive any benefit. Please vote 'no' on the proposed zoning change to allow the outdoor, mega concerts.

member of the City Council is requested to vote to table consideration of both NU Ordinance proposals for at least 30 days.

This would provide time to enable a duly authorized Evanston negotiation team acting with full advice of counsel and consistent with all previously enacted principles of sound zoning and land use obtain a revised deal from NU that can be expected to receive the approval of not less than six or seven council members.

Any approval of the NU Ordinances by less than 6 or 7 Council Members would seem to be a violation of applicable Evanston and Illinois law in the opinion of a number of Evanston resident attorneys who have signed a statement to that effect. Any zoning decision affecting any significantly large piece of Evanston controlled property impacting a large number of Evanston residents should always require the approval of at least a 2/3 majority of Council Members as a matter of good governance and equity even if such 2/3 majority is not strictly required under the particular facts and circumstances of such matter.

In the interest of demonstrating to all Evanston voters that all the members of the Evanston City Council respect good government and good government processes each

Evanston does not need this NU deal unless the terms benefit all of Evanston for as long as NU is causing disruption through hosting 6 Concerts PLUS 60 other large events PLUS unlimited other events at Ryan Field.

The traffic congestion, noise and air pollution will affect all parts of Evanston as the 28,000 or even the 10,000 attendees descend on Evanston from the North, South and West by their own cars or by taxis and ride share cars for those 6 Big Concerts Every 2 Weeks + those 60 Big Ticket Events Every 4 Weeks at Ryan Field From Memorial Day through Labor Day Every Year Forever and Ever.

Evanston does not need to grant any perpetual NU deal if Evanston does not get full fair perpetual market value.

Evanston does not need any NU deal that has been described already as worse than the infamous 75 year sale of Chicago parking meter deal.

Evanston should hit the pause button on any approval of both NU requested ordinances until Evanston gets a formally and duly authorized negotiating team in place that has been approved by a proper vote of the City Council.

That team should include at least two council members who have expressed concern about the NU demands as well as representatives from organized community groups from the 6th and 7th Wards.

Those two Wards and their residents are most adversely impacted by any physical damage from NU construction activity and NU demands to host at 66 big events plus unlimited smaller events each year and every year in perpetuity.

When the NU's selfish 66 Concert and event demands hit the fan it does not cover everyone equally.

### Will Pounding into bedrock at Ryan Field during Construction Damage Local Building Foundations?

One issue raised by one resident is that the pounding into bedrock to create pylons to support a new Ryan Field may damage the foundations of nearby homes, apartment buildings, and businesses. NU deal For 6 Concerts PLUS 60 big Events Exposes Evanston Residents to Damages with No Compensation or Rights.

The NU deal as proposed to be voted on contains:

### But the NU Chief Operating Officer publicly stated on November 15th that NU has no price tag on the CBA

But wait a minute, it has been publicly reported that on November 15th the NU COO stated to a meeting of the NU Faculty Senate that NU had not attached a specific price tag to the CBA.

And the NU COO stated (with respect to that \$175 million amount) - Quote: "Certain council members may have come to their own math".

### A November 15th Town Hall Casts Doubts on the City Council's Numbers and Processes to Negotiate the NU deal.

Meanwhile at a Town hall meeting hosted by council members Reid and Burns on November 15th, dozens of Evanston residents who attended stated opposition to the form and content of the NU ordinances, the latest drafts of the MOU and its incomplete and weak terms and schedules to protect Evanston and its residents, and the inadequacy of the CBA.

Council members Reid and Burns were expressly confronted with the NU COO statement that the CBA does not necessarily add up to \$175 million to NU..

## Council members Reid and Burns seem to declare they negotiated away any potential perpetual CBA from NU for only a 15 year CBA while NU gets to use Ryan Field to generate NU cash forever.

Both council members stated they supported only getting 15 years of NU CBA payments they negotiated rather than getting NU CBA payments for the perpetual NU zoning benefits. They stated that they asked for 20 years but settled for only 15 years.

### Council members acknowledged he had no authority from the City Council to negotiate with NU.

But here's the problem with that "deal", as noted by numerous Evanston resident's at the November 15 town hall, Council members Reid (and perhaps Burns) acknowledged that no council members were formally authorized by the Evanston City Council to negotiate any terms with NU.

There was an extended back and forth between Mr. Reid and residents as to whether it was appropriate for any Council members to negotiate anything on behalf of Evanston without first getting legal authority from the Council to negotiate.

Shame on the Evanston council members who keep peddling this "we got the best deal we could from NU" narrative. What do you mean by "we" Ke-mo-sah-be as that noted Potawatomi TV character Tonto might ask?

NU NEEDS THIS DEAL MORE THAN EVANSTON DOES.

- That 66 number is what the pertinent language from NU's proposed text amendment says: 66! We all can look it up.

With typical Evanston Weather everyone with a calendar and a pocket calculator knows that NU will have to schedule 6 Big Concerts Every 2 Weeks + 6 Big Ticket Events Every 4 Weeks at Ryan Field From Memorial Day through Labor Day Every Year Forever and Ever.

You don't have to be a weather guru to know Evanston weather will require all concerts – the 6 biggest PLUS the 60 big ones – to occur over a 15-week or less period from late spring to early fall in perpetuity.

- That's four big events outside or around Ryan Field every week with up to about 10, 000 people every year forever.
- Plus one of each of the 6 mega-concerts for 28,000 music fans inside the stadium every two-and-one-half weeks forever.

Only Six concerts at the new Ryan Field? It's not just a false deflection that hides the real number – 66. But it further deflects the obvious that NU seeks to create a massive, summer-long performance entertainment venue every year forever while claiming only to want 6 Concerts and pay Evanston nothing close to fair market value for the surrender of Evanston zoning rights.

Which leads us to NU's newer third false narrative.

### The New Third False NU narrative Involves Offering Vague Community Benefits to Evanston

On October 30, Northwestern launched its third false narrative – that it's offering the city of Evanston \$100 million in return for the zoning changes it seeks.

#### But the Media Poked Holes in the NU Claimed CBA offerings.

Fortunately, the media took a closer look at that \$100 million community benefits agreement (CBA) whopper – and it collapsed under the weight of a straightforward analysis as noted by Steve Harper in his guest essay in the Evanston Round Table as did others.

### But At Least 4 Council Members Seem to Have Bought the Claimed NU CBA Ruse And Began Unapproved Negotiations.

Unfortunately a few or more of the four council members who are vocal in their support of NU's plan to gut the U2 District have worked with NU without any formal council authority to pump up the sketchy amount on that shaky CBA false foundation.

### Some Evanston Council Members Publicly Tout that the CBA is now worth \$175 million in "Value" while NU looks on..

At the November 13th Council Meeting councilman Reid announced the NU CBA pledge is now up to a package worth \$175 million of "value".

## NU has engaged in a divide and conquer strategy with false claims about the Ryan Field rebuild. Such tactics should not be rewarded by the City Council rolling over and caving in to NU.

As noted in a recent guest essay in the Evanston Round Table, for months, Northwestern spread two false narratives framing the most consequential zoning issue in Evanston's history. The Evanston Land Use Commission exposed and exploded the first falsity. The second falsity endures.

# NU has falsely claimed that it needed at least \$2 million in Concert revenue to rebuild Ryan Field while omitting that NU is currently receiving \$60 to 100 million bucks from its share of Big 10 TV deals perhaps in perpetuity plus all other existing revenue from old Ryan Field.

That first whopper of a false narrative was NU's false claim that it needed \$2 million expected from six concerts to make the new Ryan Field financially viable.

- In the ensuing discussion, the NU's more than \$14 billion endowment had nowhere to hide.
- And let's not forget the \$60 to 100 million bucks NU will get from its share of Big 10 TV in perpetuity that NU fails to acknowledge NU will receive over the next 7 years.
- And let's not forget the additional millions NU will get for fat cat sky boxes and various naming rights for plazas, washrooms, and other spots around Ryan Field.

As they say, money talks unless NU tries to hide its revenue sources and the City Council seems willing to turn a blind eye to their fiduciary duties to Evanston and its taxpayers.

### The Zoning Commission blew up that first false NU narrative by recognizing it as false and denying the NU Zoning Change Request

I, like others, sat through the three longland use hearings before the Commission recommended approval of the Ryan Field Rebuild but denied approval of the Zoning Change request. Evanston's Land Use commissioners had a few choice words describing NU's absurd suggestion that it only asked for 6 Concerts each year: "unconvincing," "unfortunate," "not credible." Even Commission Chair Matt Rodgers, NU's possible ally, found NU's assertion "laughable."

The second false NU narrative about only asking for 6 Concerts while actually seeking approval for an additional 60 large events is even more cynical but it survives in the media thanks to NU continuing to beat that false narrative. But the second false NU narrative has not only survived, but also has dominated the media coverage of the new stadium: that NU wants "only" six concerts per year at and around Ryan Field.

- That only 6 number is incorrect. NU wants and is demanding 6 Concerts PLUS 6 large events each year PLUS unlimited smaller events forever.

SCHOOL IS IN SESSION NU GIVES STUDENTS FREE FOOTBALL TICKETS - THE SAME COURTESY SHOULD BE EXTENDED TO TAXPAYERS FOR ANY CONCERTS)

THE MATTERS SURROUNDING THESE TWO NU REQUESTS ARE LIKELY TO DRAW IMMENSE COMMENTARY OVER THE COMING YEARS. IT APPEARS TO ME THAT EVANSTON SHOULD MAKE SURE THAT THE PROCESSES IT USED TO CONSIDER THESE TWO NU REQUEST WILL NOT REFLECT BADLY ON EVANSTON OR ITS CITY COUNCIL.

The City Council needs at least 6 and probably 7 votes in favor to approve these Ordinances and related materials to make any such approvals legal and legitimate in the eyes of most well informed Evanston taxpayers.

If each of NU's Proposed Ordinances can not get a 2/3 majority from the from the entire 10 members of the Evanston City Counsel that is strong evidence the NU Ordinances are bad for Evanston or at least in inadequate form or substance. I believe a 2/3 majority is required by both Illinois state law as well as Evanston administrative law. That 2/3 majority for the 10 member City Counsel would require not less than 7 votes to pass. Even if Evanston were to be able to get away with just requiring a simple majority for that 10 member City Council would require not less than 6 votes in favor to pass.

If the City Council cannot get those 6 or 7 votes in favor of the NU proposals then the matters must be denied or perhaps tabled again to go back to a properly authorized negotiation that might become acceptable to a 2/3 majority of the Council.

It does not take a mathematical genius to recognize that the issues surrounding these Ryan Field actions have stirred unprecedented opposition. If these changes to the permitted events at Ryan Field are indeed generational changes then it would seem the City Council should exercise extreme care in how it proceeds in negotiating the terms of all Ordinances and related agreements. Without support from at least 7 Council Members these Ryan Field actions should be tabled for at least 30 days to see if better more Evanston friendly ordinance and MOU terms can be proposed and negotiated that benefit all Evanston residents so that the City Council can gain and earn a 2/3 majority vote of 7 council members or at least 6 council members required to pass these actions.

Break the Ordinance approving the rebuild and the Ordinance seeking zoning changes into two separate and distinct actions as has been recognized by the Zoning Commision and most informed taxpayers and voters.

And if that 2/3 approval for each of these two NU ordinances cannot be obtained then those Ordinances should be broken apart as it was obvious to anyone with half a brain that NU cynically linked them to attempt to pressure the City Council to consider them as a package. an keep getting tabled for 30 days or longer until that 2/3 majority is achieved for better terms to protect Evanston and impacted residents around Ryan Field.

In today's Daily Northwestern (excerpted below) it quotes the Mayor as having the impression that UPIC is affiliated with NU.

The group has made significant donations to his political campaigns in the past. While Biss says those donations are "their problem, not mine," I believe that Mayor Biss should recuse himself from the vote tonight.

While I encourage you to vote NO for myriad reasons, I would specifically request that the Mayor not allow himself to cast the tie-breaking vote. If Ald. Geracaris recused himself, then Biss should, too.

Elected officials should always recuse themselves, if there is even the appearance of impropriety. On an issue of such important magnitude, there should be no grey area.

In fact, many have wondered if Biss didn't appoint Ald. Geracaris knowing that he would necessarily have to recuse himself, giving Biss himself a vote on any matter related to NU.

I urge you to vote NO on this issue, and also to ensure that the Mayor not have a vote.

Biss, Evanston's mayor, received \$9,000 in donations from UPIC while serving as a state representative and senator from 2011 to 2019, according to FEC filings. For part of his tenure, he served on the Illinois House Committee on Appropriations-Higher Education.

Biss told The Daily he had the "impression" that UPIC was affiliated with NU. For him, that affiliation raised questions.

"What is the governance of an organization that is, by tax law, necessarily independent of the University but also is kind of seen as affiliated with it?" Biss said. "What does the word 'affiliated' mean?"

He did not hesitate to take the donations, though. Those questions were "their problem, not mine," he said.

Dear City Leaders -

As a 27-year resident of Central Street across from Ryan Field, a graduate of Northwestern University and someone with family roots in Evanston going back to the late 1800s, I encourage you to vote "no" on the rezoning and MOU.

I've followed the process since the first public Land Use Commission meeting, and while I can't possibly claim knowledge of every detail, implication and impact of the proposed rezoning and MOU, it feels to me to be heavily weighted in favor of the university in terms of control, and puts the City at considerable risk not only to realize the proposed benefits, but also to the responsibilities and costs the City could bear (police, fire, traffic control, infrastructure, insurance, staffing and the like) and the impact on the Central Street neighborhood. This control could, for example, be used to force the City to agree to additional events over and above the 66 additional events currently under proposal.

I understand that the university and its investors are putting up a lot of money for the stadium and have their own risk-related concerns, but it's also not incumbent on the City to assume undue risk in order to support a private non-profit university's goals of for-profit commercialization.

I'm also concerned that, as a Central Street resident, the Land Use Commission's concerns about infrastructure, parking and traffic in the immediate neighborhood (including many condos and apartments that don't have sufficient off-street parking) - concerns that led to them recommending against the rezoning - haven't been sufficiently addressed and will "be figured out later". While I'm not asking you to "vote NO on something that could benefit the City as a whole because a relatively small percentage of overall residents will find it more difficult to park and navigate our neighborhood during the 66 additional event days", I am concerned that little to nothing has been mentioned so far to attempt to address this challenge other than being told repeatedly that I can "feel free to leave the city during event days" or "park downtown and take the L with the event-goers".

I do support the spirit and goals of many aspects of the proposal, including benefiting underserved communities in the City and funding education and increasing minority job opportunities, but I'm concerned that the control the university would be granted over the direction and outcomes of the MOU gives them undue leverage against the City to actually realize these benefits.

From the beginning of this process I've felt that an open, community/university partnership approach to this could (and may still) result in something that works for all involved. But in its current form it feels that the City benefits that could be realized are too much under the control of the university.

Hi. My family lived at \_\_\_\_\_ in Evanston for over 10 years, and we are now one block over the border with Wilmette, near Ryan Field. We are considering moving back to Evanston in the next five years.

We implore you to consider the impact on the surrounding community if you rezone and expand the events at Ryan Field.

We cannot invite anyone to our home on game days. We cannot let our kids ride their bikes or play out and about. It's not safe due to the many cars circling and driving unsafely through our street, one block north of Isabella. The traffic is a logistical nightmare on game days for those of us who live near Ryan Field.

Although the traffic and parking situation is rough on game days, we knew about these days and accepted the trade off when we moved to 6th and Gregory. Having night concerts, more events, and a larger venue will be devastating for local families & property values. At least now people roaming through our alleys and yards, and driving around aimlessly looking for parking are doing so during the day. And it's a manageable number of game days. I dread what we'll see if this rezoning plan moves forward.

I understand that people who don't live near the stadium may not care. And I don't currently vote in Evanston, so the impact on my family may not matter much to the people making this decision. But I am a strong supporter of Evanston. I do most of my shopping in Evanston, and support the city by paying for programming at the Evanston Art Center, The Levy Center, The Ecology Center, Farmer's Market, and the Chandler-Newberger Center. My daughter attended NU CTD classes at Roycemore. We see a pediatrician in Evanston and use Evanston Hospital. We buy our bread at Hewn and bank in Evanston. We shop at the Spice House and the local shops and restaurants along Central Street, Evanston. In other words, we love Evanston and are part of your community, even if we are not voting in your city elections.

We implore you to respect the local residents of Wilmette and Evanston who will bear the brunt of a traffic, parking and noise situation that has been vastly underestimated by Northwestern and those who support expanding the venue.

How will people get to the hospital's emergency room with the crowds around the stadium? It's unsafe and there isn't a way to quickly route around the crowds from the neighborhood. Even the fire department right next to the hospital may get locked in by the crowds.

We have contributed money to have an unbiased company do an assessment, and the news is not good. Public transportation (much of it through Wilmette) cannot accommodate the expected crowds, and our streets & parking will be inadequate to handle the volume of cars expected. I am shocked that Evanston's own land commission's recommendations haven't been honored. Wilmette's village board has voted to oppose the expansion, as you know.

Please think beyond the shiny new promises from NU. They don't need the money and I think this expansion will hurt more than it will help, when you net it out. It's unfair to us who live here and I am sure you wouldn't want this in your backyard.

We will probably move north if you approve this plan. And we won't return to Evanston, which we would like to do.

I have always been a supporter of you, Mayor Biss. I remember you ringing my doorbell at 2949 Harrison Street and introducing yourself during your first campaign. I have always agreed with your politics, and I have always believed in

#### City Council and Mayor

I preface my comments by noting I am a 3-time Northwestern Alum and 20 year football season ticket holder. I support their Northwestern's right to erect a new stadium.

Northwestern has generously agreed to contribute to the financial health of our city and its citizens; however I have deep concern about signing this proposed agreement with Northwestern, for 2 reasons.

First, the math makes no sense. Northwestern is building an \$800M stadium, without a plan to finance maintenance, for what they say is \$2M/year. The annual Northwestern budget is \$2.9B (yes BILLION); \$2M is 0.07% of that budget. Their endowment is \$16B; assuming a paltry 5% annual return, or \$800M/year, this maintenance cost would be 0.25% of that amount. So clearly, Northwestern can easily afford this amount without subjecting our neighborhood to the well-documented disruption that concerts would bring. In short, they do not need to hold concerts for the reason they state. If that is the case, Northwestern is being disingenuous at best, and deceitful at worst. What is the truth? We do not know, but we do know that what they are telling us is not the truth.

Secondly, signing any agreement in perpetuity is bad strategy in ANY agreement. If you sign this agreement, you are sentencing our neighborhood to potential disruption FOREVER. Children and elderly trying to sleep, homeowners and renters unable to enjoy their yards every other weekend through the summer, with potentially drunk, stoned and disruptive concertgoers flooding our sidewalks at 10PM. Forever. Think about that.

Northwestern is not walking away from their stadium plans - everyone knows that. We have something they want, no, *need*, and we should negotiate with that in mind. I urge you not to settle on these points - no concerts, no "in perpetuity" clauses.

Hello ~

20+ years ago, a little boy was hit by a car at an intersection near us in Wilmette. I will never forget seeing him lying unconscious in the street. The next time I saw him, he was being pushed in a stroller in a full body cast.

Thank God this hasn't happened again near us. But this past summer, as I found myself driving down local streets where kids on their bikes were taking up entire lanes, I thought about what the traffic might be like around events at a Ryan Arena and pictured it dwarfing walkers, runners, bikers, kids.

At first, I thought I might ask that any proposal from Northwestern deal with ensuring a suitable infrastructure for heavy truck and bus traffic. But I don't think that's the right priority. Pedestrian deaths in the US are soaring. Cars and trucks don't need facilitating, people and bikers do. A narrow-streeted residential area is not the place for heavy commercial traffic.

The trend nationally is for streets to be engineered to slow cars down and to be more friendly to walkers and bikers. Evanston should be in accord with this trend.

I hope that you will not vote to rezone according to any proposal that does not take pedestrian and bike safety into account.

### Dear City Council,

I love my City, respect and honor each one of you, but I am very concerned about the ramifications of giving away our zoning rights (over concerts). It is outrageous to even consider changing our zoning rules with no rights to take them back is unfathomable.

I urge each of you at this time to step up and take strong leadership positions here with the stadium issue. It's clear to everyone that NW is not going to provide any sort of great "deal" that makes holding a handful of concerts worth destroying our neighborhoods for. Their continued coming back with last minute new "improvements" that are really minimal embarrasses me to live near them. You'll recall they originally needed only about \$3 million per year to make the new stadium economically feasible. No one believed that then and no one believes it now. Why would a brand new, green, efficient, state of art facility require more money to run it?

At a minimum, you <u>must not approve</u> any zoning change that can't be taken back. For example, what if concerts were to end up being the worst thing that ever happened to Evanston, and to our neighborhoods? What would my (the City Council's) remedy be? This Northwestern pursuit of a few million in concert tax revenue sets the City of Evanston up for lawsuits that could bankrupt the City down the road. And this doesn't even consider the Village of Wilmette's potential legal actions due to noise issues, depressed home values, etc, all due to NW seeking s few million extra dollars to operate the new efficient, green stadium. Anything this divisive and controversial must be either stricken completely or at a minimum, delayed until you've gotten protections and proposed rule changes that allow the City of Evanston to keep control over our neighborhoods' futures.

Again, I urge each of you to take a <u>strong leadership role</u> and perhaps propose allowing <u>one concert</u> in the first two to three years to see how it goes. If it goes well, NW can lobby Evanston to <u>allow more</u> (we'll have hard data at that time to make such a decision). If it goes poorly, then Evanston can shut it down. In this case, <u>we</u> retain control over our neighborhoods.

Please step up and show everyone who you are as leaders and protectors of our neighborhoods. The suggestion above may not be acceptable to NW, but it would also not give away our terrific, family based neighborhoods to folks who don't need our money in the first place.

Come on City Council, show us who you are as leaders!!

- 1. When did Mayor Biss start negotiating with representatives of Northwestern and/or Pat Ryan and when did he make a deal with them for his vote?
- 2. Why does the agreement effectively bar the City of Evanston from ever changing the zoning again by letting Northwestern sue to stop the City from doing so?
- 3. Why does the agreement let Northwestern stop paying all the purported public benefits if the City later changes the zoning?
- 4. Why does the agreement allow Northwestern to reduce the public benefits "at Northwestern's discretion" if the City imposes "unreasonable restraints" on concerts?
- 5. Would enforcing local and state laws against noise pollution constitute "unreasonable restraints"?
- 6. Why does the agreement fail to specify significant penalties if Northwestern violates its provisions on security, traffic, and other measures designed to protect residents?
- 7. Why is there still no reimbursement schedule detailing how Northwestern will pay the City for police, fire, and parking enforcement services?
- 8. Why is Northwestern making its "Good Neighbor Fund" payments to the City contingent on rezoning when its peer universities make payments in lieu of taxes (PILOT) to their hometowns without demanding to rewrite their laws?
- 9. Why is Northwestern giving nothing to Evanston's public schools (the only purported public benefit for schools would come from a surcharge on concertgoers) when it can afford to pay the University of Texas-El Paso (UTEP) \$1.2 million to come play a single football game?
- 10. The Johnson Consulting report commissioned by the City cited "a number of questions that remain unanswered in the transportation analysis. It is recommended that the transportation analysis be revised…." Why haven't these questions been addressed before granting a permanent zoning change?

I am strongly in favor of a new Ryan Field allowing concerts. This is a once in a lifetime opportunity with no taxpayer funding.



We are a group of students from Regina Dominican High School in Wilmette, and we recently examined the Ryan Field development in our "Justice in Action" seminar.

After exploring how this development might impact the community, we have some thoughts!

We would like to advocate against the proposals to rebuild Ryan Field and allow concerts

#### Here's why:

- **Increased crime**. Rebuilding the Ryan field and allowing concerts will increase crime rates in the Evanston area. Since Evanston/Wilmette is a kid-friendly neighborhood, bringing people from around the world for large events could spike by bringing questionable crowds. Thus diminishing the childhood/friendly aspect.
- Increased traffic. The increased traffic in the area will delay emergency vehicles and have
  their service for the city of Evanston decrease. The amount of parking spaces will also not be
  equal for the concert venue, which will result in people having to park in the local residences.
  This will disrupt the lives of the public as the influx of people brought in by the concerts will
  cause miles of congestion.

By initiating the over 800 million dollar plan to renovate and rezone the Ryan Field, several issues will arise due to the incursion of people through the surge of traffic, crime rates, and the desuburbanization of the Northwestern community. We strongly advise the overruling of this plan, as it will forever ruin the character of the city and demolish the tight-knit community formed over decades.

"Any uses not outlined herein shall require approval by the City's Special Events Committee."

Are such non-City and non-University events unlimited in frequency? Are they capped at the capacity size of any facility in the U2 District?

In 2019 during the Welsh Ryan Arena Concerts proposal debates at Council, the Members did discuss the relative simplicity of the Special events Committee approval process vs the more arduous process of getting an approval by City Council. Remember also, that no community input is involved in a City's Special Events permit process.

In summary: anybody saying "it's just six concerts" has not read and/or understood the Text Amendment proposal's language.

On October 30, the Councilmembers and the Mayor did not examine in detail or extensively discuss the actual language of the proposed Text Amendment. On November 13, the "magnificent four" Councilmembers and the Mayor already openly stated their future vote to approve the proposed Text Ordinance, and thus dismantle the Evanston Municipal Code's right to ever amend it ever after. On November 20, deliberations will be meaningless since the outcome has already been announced. I would be very surprised if the Text Amendment itself would be given more than a fleeting comment, or if the MOU at least would be amended to correct the lack of recourses for Evanston vis a vis Northwestern, which also would include a Sunset Clause, a clause that Councilmember Nieuwsma, back in July, told me was an excellent suggestion that he would pursue.

These five people, are sweeping under an "MOU carpet" which unilaterally protects Northwestern, the misleading and unacceptable Text Amendment proposal language I mentioned above. For perpetuity, the Mayor, and four Councilmembers are going to allow Northwestern to turn the U2 District into a commercial venture, to host an unlimited amount of commercial and other types of sports events, including unlimited musical performances. All events will be able to contain very large crowds and pummel Evanston neighborhoods with compounded detrimental effects of noise, traffic and vehicular pollution.

It is not "just six concert evenings".

I can almost forgive the members of the community at large who did not understand or even read the proposed Text amendment. After all, many of them rely on the Council to do the work and to look out for the City's interests. In this instance however, that reliance has been naïve and dangerous. The City is selling its municipal rights for a pittance that will end in a blink of an eye. What are 10-15 years? At the end of that period, there will be no leverage for the City to ask Northwestern for anything in return.

Think back, and realize that Northwestern also got the perpetual right to be a non-property tax paying entity. How many of you now believe that such a decision then, turned out to be disastrous for Evanston's tax payers? Council again, is entering into a perpetual contract that cannot be undone. The future residents of Evanston, the future Councils of Evanston will rue the day the current Mayor sold Evanston municipal rights for "30 pieces of silver".

My information is derived from the following City documents:

"University-sponsored lectures, speakers, musical performances and other cultural events held within an enclosed building provided that attendance is limited to ten thousand (10,000) or less."

At any rate NU can host amateur sports and any type of athletic events with no capacity limits and with no limits on frequency.

Page 2: The section called "New Section" allows "musical performances hosted by the University or City, designed for the University or local community" and with capacity "no greater than 7,500 and, and no more than 60 days of programming". "Loudspeaker permits required for any noise amplification".

The question is: How many decibels does the city permit allow for such loudspeakers?

Imagine, just in terms of loudness alone, 60 days of longer duration Out-of-Space concerts in the Plazas. I remind readers that as of now, the Golf Course concerts are much smaller in attendance and very limited in frequency compared to the "limits" proposed for Plaza musical performances (60 events up to 7500 attendance). Furthermore, the musical performance in the outdoor Plazas don't have a time limit of three hours.

Page 2. "Such events shall not include any outdoor plaza rentals to organizations not affiliated with the University or City". That means, outdoor plaza rentals are not part of the 60 day/7500 limit. The language does NOT state that plaza rentals would be prohibited.

The questions are: What type of organizations are those "outside" organizations? What is the limit in attendance? How often per year? Is there any oversight by the City for the parameters of the rentals?

Page 3: Below that "New Section" box, there is another box which allows "private event uses, including weddings, philanthropic events, weddings, birthdays", "provided that attendance is limited to the capacity of the specific facilities".

Philanthropic is a vague term. Exactly what could these events be?

Weddings and other festive celebrations are generally accompanied by music. The new stadium could be used for yet more musical events, and celebrities could have unlimited private celebrations with large amounts of "invitees and guests". In fact, the "off-street parking" section of the Text Amendment adds the allowance of "guests and invitees".

Page 4: "Vehicles may only idle in approved designated areas on private property".

Pollution cannot be contained in underground docks.

Page 4: Another worrisome additional "New Section" appears at the end of the Text Amendment: a section about which Land Use Commissioner Lindwall did ask questions, but received no satisfactory answer from Northwestern. The section reads:

Five people have already decided to eliminate the right of the City of Evanston to control its own Zoning, and are poised to vote in favor of a deeply flawed, unexamined Text Amendment, and an MOU that has not been legally scrutinized at length by independent Counsel.

What struck me most about the Council discussions regarding Northwestern's MOU were several items: The unilateral "reliance clause" (in Recitals) coupled with the "for perpetuity clause" (#12); the ease with which NU could reduce and/ or eliminate benefits (9); and the ease with which NU could deem City changes to submitted traffic and other plans unreasonable (5;6;7; 11).

Moreover, there are no indemnity provisions for structural damage incurred to residents' properties during construction (15 g). And the indemnity only covers the 6 concerts in Ryan Field, but none of the other additional events spelled out in the proposed Text Amendment.

I'm flabbergasted at Councilmember Nieuwsma's contradictory statements on November 13 regarding the new MOU: "I haven't even had a chance to read the document yet", followed by, [the City has] "a really, really, very good deal in front of us". He then openly declares his opposition to continue negotiating with Northwestern.

But there is even more to be concerned about. Something else compounds and explains why four Councilmembers and the Mayor are so unanimous in desiring to pass the proposed Text Amendment Ordinance. It is their lack of deliberations about the actual language of the proposed Text Amendment, before voting in favor of introducing the proposed Text Ordinance, that made it very easy to push for the "money" argument, and be blind to the repercussions inherent to what will actually be allowed in the proposed Text Amendment.

There are several passages in the Text Amendment which demand scrutiny. I'm specifically referring to

And if this Text Amendment is not scrutinized and discussed by Council, the consequences would compound the effects of congestion, traffic and noise to a level far exceeding "just six concerts".

### Just a few passages of concern:



Hello,

As a lifelong Evanston resident - someone who grew up going to D65 schools, and then ETHS - I am deeply proud of my community and our leadership on critical issues at a regional and national level. It's why I returned to raise my own family here as a resident of ward 6. And I am excited about the potential that a new stadium presents to our community - concerts included - but I cannot in good conscience support this effort knowing how unfair this deal is to our community. It's abhorrent, and as our elected representative, I expect you to be fighting harder for our community.

It is not lost on me how complex our community's relationship is with our academic neighbor, Northwestern University, but what I can't comprehend is how we can continue to justify NU's lack of care, concern and commitment to our residents. They have benefitted from tax-free access to a significant portion of our community (not to mention they continue to outbid normal residents in the race to secure residential homes, taking from families who are looking to build their lives here but cannot compete with a university that has a multi-billion dollar endowment and faces no property taxes.)

Again, I cannot begin to understand how an organization like NU, who falsely parades guiding principles on their website, such as "strengthening our community", but does not follow-up these statements with actual action and commitment. It's false advertising and any corporate entity would be reputationally destroyed for making empty promises like this. We need more accountability and good will from the university. We deserve it.

We have been deeply impacted by a lack of care and commitment from NU. Our parks are in disarray. I attended a recent community meeting to review the plans for Independence Park (which are very disappointing to say the least) and learned that a majority of Evanston's parks are nearly 25 years old. My own two-year-old daughter cut her eye on a rusty stair at Cartwright park and had to be taken to urgent care. Mr. Suffredin knows this first hand as he promptly addressed the issue by replacing the rusty equipment, for which we are grateful. But it's insane that we are faced with these conditions! It's embarrassing.

With phased construction targeted for 2024 and 2025, some attendees said that repairing or replacing aging playground equipment needs to be prioritized in the meantime. One person said her daughter recently suffered a severe cut underneath her eye due to a rotting step at another city playground, and is concerned about old equipment at Independence Park posing similar risks in the months ahead of construction. - Evanston Roundtable

We lost our local library on Central St. leaving a huge hole in our community for gatherings and enriching programming. Not to mention, the only public restroom in the entire Central St. Business District. How can that not present the most obvious opportunity for NU to stand up and invest in our community to reopen these types of facilities, as a self-proclaimed steward of "excellent teaching, innovative research and the personal and intellectual growth of its students in a diverse academic community"?

These are just a couple examples. But we deserve to demand more. That is why I am desperately asking for you to reconsider your tie-breaking vote and push NU for more money earmarked for our public schools and for the financial investment to be for the entire life of the stadium and not just 15 years.
