# Our Purpose, Vision and Values



#### **Purpose**

The Evanston Arts Council nourishes and builds an inclusive community where creative expression thrives and the arts flourish. We empower and amplify artists and arts organizations as community builders and change makers. We support diverse forms of expression and provide equitable access to the arts.

#### Vision

We envision the arts as central to an equitable, sustainable city where authentic and diverse creative voices are accessible to all; and where artists are supported, thriving, and recognized as fundamental to a healthy and engaged society.

#### **Values**

- We maintain that art is for everyone; it should be a catalyst for inclusivity and equity.
- · We support decolonization of the arts and all forms of creative expression.
- · We value the voices of artists to enrich lives and move society forward.
- · We believe the arts are a vital reflection of our humanity.

# The Cultural Fund Application: Overview



- 2024 Maximum grant award: **\$6,000**
- Eligibility
  - Open to 501(c)3 organizations
  - Must serve Evanston, but need not be located here
  - 501(c)3 applicants must have a SAM.gov Unique Entity Identifier number
  - Individual artists cannot apply (apply for the Special Projects Grant instead)
- Organizations can apply for specific programs <u>and/or</u> general operating costs of an organization
- Simple, short application: Just three narrative questions

# **The Cultural Fund Application: Overview**



The Arts Council encourages new, first time applicants and prioritizes the following Cultural Fund applications:

- from Black, Indigenous and People of Color-led organizations
- from LGBTQIA+ led organizations
- from and/or serving all marginalized and under-resourced groups, including older adults, neurodiverse individuals and those with disabilities, immigrants and refugees, and vulnerable youth
- that collaboratively bring the community together

# **Equity and Accessibility Requirements**



- Organizations should place a high priority on community access. Applicants should demonstrate strategies for outreach to the community.
- ✓ The applicant organization must demonstrate their efforts to realize the Equity in the Arts Goals set by the Arts Council, to:
  - Promote equity and inclusion throughout the arts in Evanston, regardless of gender, race, ethnic background, age, ability or sexual orientation.
  - Ensure that the cultural arts programs the Council supports reflect the diversity of the Evanston community.
  - Make the arts accessible to all people, including those with disabilities.
- No person will be excluded from participation on the basis of sex, race, sexual orientation, color, religion, ancestry, age, national origin, or ability.
- Make every attempt to ensure that the proposed project is accessible to persons with disabilities.

### We Cannot Fund



- Individual artists
- $\times$  Non-501(c)(3) arts and 501(c)(3) community organizations.
- Capital improvements or construction costs
- Organizations whose activities occur in non-accessible venues
- Purchase of permanent equipment
- X An existing deficit from a previous year or project
- Activities not open to the general public
- Scholarships, social or fundraising events
- ➤ Personal expenses e.g., childcare and wages lost due to proposed project commitment
- Applicants that submit incomplete applications
- Applicants that are taxing bodies (including schools, libraries and park district)
- X Applicants that are neither located in Evanston nor serve the Evanston community
- Food or drinke
