## **City Support Programs**

#### General Assistance/Emergency Assistance

#### General Assistance

- \$473,747 total expended in FY 2023
- 129 HH, max allowable \$985 per month

#### Emergency Assistance

- \$39,713 total expended in FY 2023
- 31 HH, one-time payment up to \$2,000

#### Additional Services

 GED, Adult Basic Ed. courses, financial literacy, mental health/substance abuse treatment

## Community Member Relief Fund/Refugee Assistance Program

- One-time relief payment to vendor
  - \$29,290 expended
  - 16 HH assisted/payments primarily for rent
- Specifically for HH not qualified for EA/GA
- Life-threatening event (eviction, utility disconnect, etc.)

## Guaranteed Income Program (11/2022-11/2023)

- \$900,000 in direct subsidies provided
- 150 Participants
  - Adults 18-24 years old & adults 62+, undocumented
- Eligibility: HH income ≤250% Federal Poverty Line
- \$500 per month for one year
- Renewed for 2024

- ESG Rapid Re-Housing:
  - \$39,057 total: \$15,117 to HH \$23,939 staffing
  - 7 HH/17 persons

#### Match Requirement:

#### **ESG Match/Leverage Example**

Funding for other "pass through" grants may not include staff costs

  - Funds would support housing services to citizens with Refugee status,
    Asylum seekers, and grantees

#### **Category Objectives**

#### Holistic Case Management

Enables households to thrive in our community

#### Safety Net Services

 Provision of food, domestic violence services, emergency shelter & street outreach

#### Support Services

 For low- and moderate-income Evanston residents including mental health care, child care, legal services, employment services, substance abuse counseling, etc.

### Considerations

#### **SSC Input from February Meeting**

- Provide benefits enrollment/links to services
- Support residents & improve community
- Help residents remain in Evanston
- More detailed financial review (impact of loss of funding)
- Mid year review of outcomes
- Reducing admin burden (minimum award amounts)

#### **Current Assessment Challenges**

- Program/Agency Budget Information
- Quantification of Service Impact
  - Ability to meet current needs (waitlists)
  - Identified gaps in service net (needs that aren't being met)
- Increased Capacity to serve Evanston residents

#### **Suggested Recommendations**

- Services to Evanston Residents
  - Preference for programs that serve >50% residents
- Equity Impact
  - Preference for programs that serve >50% BIPOC residents
  - Consider prioritization (example: services that support housing or education access)
- Reduced frequency of full application/ increased length of application cycle (in keeping with best practices)

#### Current plans underway

- Strategic Housing Plan (August)
- Inclusionary Housing (September)
- Comprehensive Plan (October)
- HUD 5 year Consolidated Plan (November)

Wraparound Services (ongoing negotiations/TBD)

#### **Staff Recommendations**

- Ongoing Assessment of Services
  - Review of community assessments to help identify needs
  - Continue updating reports for existing services
- Extension of grant cycle: 2024/2025
- Open new grant cycle for FY 2026 funding next year
