She would like to give back to the Evanston community. Commissioner Sexton shared she is a social worker. She works with children with disabilities.

#### 4. DISCUSSION

## A. Metropolitan Tenants Organization Presentation by David Wilson

David Wilson of the Metropolitan Tenants Organization (MTO) shared that he works to educate and empower tenants regarding their rights. Mr. Wilson also assists tenants in forming tenants associations. MTO has a hotline where tenants can inquire about their rights. MTO provides tenants with the tools to get the job done.

Mr.Wilson mentioned the Just Cause Ordinance. If the ordinance is passed, landlords will have to provide their tenants with a reason to move. The Housing Authority of Cook County (HACC) building formed the first tenant association in Evanston. Trisha Connolly shared that the tenant association

also works to build community - they pay a fee that can be used to host parties and other things. Tenants could also advocate for rights collectively and elect a board. Ms. Connolly also shared that a tenant association could also provide a sense of leadership and communication with their building.

#### E. Referral tracker

## Referral tracker

Commissioners reviewed the referral tracker. There were no equity issues. The Commissioners shared they would revisit the referral pertaining to the Stretch Energy Code ordinance.

## F. Affordability of Senior Center Membership

Audrey Thompson, Director of Parks and Recreation, provided statistics on the number of meals provided and donations collected. The data shows that the City takes in less funding than the services provided. The Levy Center, which is a 501(3)c, assists in paying for other programs. Ms. Thompson provided a list of services that are provided to seniors with their \$50 membership card. Fees could be 70% off base on a sliding scale.

## G. Inclusion at Summer Camps

Matt Poole, Assistant Director of Parks and Recreation, provided a summary of camp staff training around understanding nuances of gender diversity. The training was adopted from Chicago Public Schools. Audrey Thompson, Director of Parks and Recreation, referred to the Daddy Daughter Dance and shared that the department renamed the dance to "Kiss Dance."
