## A. TIF Supported Infrastructure - Lara Biggs, City Engineer, Public Works

Presentation Posted

Biggs presented infrastructure

Virna asked about power lines / (including power lines on residential streets)
Discuss with Lara - cost per linear mile / linear foot, etc.

Burns suggested bike lanes to address difficult vehicular aspect

Heather - extended bike path

Flax - EV charging stations

Parking. Lot by skate park - restripe and extend (MWRD?)

Burns would like staff to present on potential to implement heated sidewalks including a review of available technology, suitability in our climate, cost and benefits, and perhaps implement a pilot program. (future presentation date tbd)

What impact would closing off the Ashland spur off of Green Bay Road (currently there is a landscaped triangle area with a sculpture. Perhaps closing off ashland would provide more space for skate park and business district events / food trucks, etc.

Street /traffic calming at Emerson - perhaps implementing a safe routes to school with assigned crossing guards / pedestrian crossing markings / blinker signs - TBD.

Does the city have a Bike racks standards? New transportation and mobility coordinator will present at a future meeting. Today, racks are generally placed when businesses ask for racks to be located nearby, after determining if site is suitable.

Zalmezak will send meeting notes to group members, perhaps create a survey or a notes gathering mechanism (subject to FOIA / Open Meeting Act requirements)

"Dwayne - "pixie dust" creative process to come up with unique ideas" - perhaps host a brainstorming session at a future meeting.
