2024 Alley and Sidewalk Improvements

July 8, 2024

Project Description

The 2024 Alley and Sidewalk Improvements project will be taking place over the next five months. A summary of the project locations and scope of work is provided below:

Alley North of Leonard Place, East of Green Bay Road	Alley Improvements, including storm sewer installation, concrete pavement, and restoration
Alley North of Colfax Street, East of Bryant Avenue	
Alley North of Simpson Street, East of Ashland Avenue	
Alley North of Lake Street, East of Darrow Avenue	
Grant Street and Grey Avenue	Pedestrian Crossing Improvements, including sidewalk removal and replacement, ADA ramps, and striping
Oakton Street and Callan Avenue	Pedestrian Crossing Improvements, including sidewalk removal and replacement, sidewalk bump-outs, ADA ramps, LED pedestrian crossing signs, and striping
Thayer Street and Crawford Avenue	
Washington Street and Asbury Avenue	
Centennial Park Picnic Pad	Installation of ADA compliant sidewalk, concrete picnic pad, and picnic accessories
Community Development Block Grant (CDBG) Sidewalk Improvements	Removal and replacement of deteriorated sidewalk adjacent to St. Francis Hospital

Sidewalk Improvement Program	Removal and replacement of deteriorated sidewalk in Phase 1 locations (school walk routes and senior living facilities) throughout the City
Traffic Calming Humps and Bumps	Installation of speed humps and alley bumps at various locations throughout the City
Transit Stops	Installation of ADA compliant concrete sidewalk at various transit stops throughout the City

Project Schedule

The project is anticipated to begin within the next two weeks and be completed by the end of November. The exact dates of construction activities scheduled to begin will be noted on the temporary construction zone “No Parking” signs posted a minimum of 48 hours in advance of the work. Parking will be prohibited during daytime work hours (7:00 AM to 5:00 PM) while construction takes place. Street sweeping parking restrictions will be waived for a one block radius around the construction zone when temporary daytime no parking is in effect. Every effort will be made to complete the work in a timely manner to minimize any inconveniences caused by the construction.
