#### <u>General</u>

#### **INSTRUCTIONS TO BIDDERS**

6. WITHDRAWAL OF BIDS

Delete following paragraph:

"Bidders may withdraw or cancel their bids at any time prior to the advertised bid opening time. After the bid opening time, no bid shall be withdrawn or canceled for a period of sixty (60) calendar days. When contract approval is required by another agency, such as the Federal Government or the State of Illinois, no bid shall be withdrawn or canceled for a period of ninety (90) calendar days."



And replace it with the following paragraph:

"Bidders may withdraw or cancel their bids at any time prior to the advertised bid opening time. After the bid opening time, no bid shall be withdrawn or canceled for a period of ninety **(90)** calendar days. "

#### **Specifications**

- 1. WATER SERVICE LINE (ARTICLE 562.03)
  - A. Delete following paragraph:

"Water Service work to replace the private-side of the water service will be paid for at the Contract unit price per EACH service connection for SHORT PRIVATE-SIDE LEAD WATER SERVICE LINE REPLACMENT, 2" DIA OR LESS, less than 15 LF in length (from curb box to existing lead to copper connection at the property line), counted in place. The first 15feet of exterior copper pipe shall be included with this price. Remaining exterior copper pipe shall be paid for using the EXTERIOR COPPER PIPE line item."

And replace it with the following paragraph:

"Water Service work to replace the private side of the water service will be paid for at the Contract unit price per EACH service connection for SHORT PRIVATE SIDE LEAD WATER SERVICE LINE REPLACMENT, 2" DIA OR LESS, <u>up to</u> 15 LF in length (from curb box to existing <u>exterior</u> <u>lead-to-copper connection</u>), counted in place. The first 15-feet of exterior copper pipe shall be included with this price. Remaining exterior



copper pipe shall be paid for using the EXTERIOR COPPER PIPE line item."

B. Delete following paragraph:

"Water Service work to replace the private-side of the water service will be paid for at the Contract unit price per EACH service connection for LONG PRIVATE-SIDE LEAD WATER SERVICE LINE REPLACMENT, 2" DIA OR LESS, less than 50 LF to in length (from curb box to interior surface of house), counted in place. The first 15-feet of interior copper pipe shall be included with this price. Remaining interior or exterior copper pipe shall be paid for using the INTERIOR COPPER PIPE line item or EXTERIOR COPPER PIPE line item."

And replace it with the following paragraph:

"Water Service work to replace the private side of the water service will be paid for at the Contract unit price per EACH service connection for LONG PRIVATE SIDE LEAD WATER SERVICE LINE REPLACMENT, 2" DIA OR LESS, <u>up to</u> 50 LF in length (from curb box to interior surface of house), counted in place. The first 15-feet of interior copper pipe shall be included with this price. Remaining interior or exterior copper pipe shall be paid for using the INTERIOR COPPER PIPE line item or EXTERIOR COPPER PIPE line item, <u>respectively</u>. "

C. Delete following paragraph:

"Water Service work to install exterior copper pipe less than 15-feet from the curb box to an existing water service shall be paid for at the Contract unit price per LINEAR FOOT for EXTERIOR COPPER PIPE, up to 2 inches in diameter."

And replace it with the following paragraph:

"Water Service work to install exterior copper pipe greater than 15-feet from the curb box to an existing exterior lead-to-copper water connection for short private side lead water service line replacements, or greater than 50 feet from the curb box to the interior surface of the house for long private side lead water service line replacements, shall be paid for at the Contract unit price per LINEAR FOOT for EXTERIOR COPPER PIPE, 2" DIA OR LESS."



D. Delete following paragraph:

"Install any electrical grounding across meter at the completion of the work. All electrical work shall be performed by an electrician licensed by an accredited licensure commission."

And replace it with the following paragraph:

"When existing electrical grounding is grounded to the water service, and is either disconnected or otherwise is required to be re-installed or modified, the Contractor shall re-establish electrical grounding to the newly installed water service. Splicing of the existing grounding wire is not allowed. Contractor shall utilize an electrical contractor registered in the State of Illinois to re-install electrical grounding in compliance with Chapter 6 (Electrical Code) of the City of Evanston Code of Ordinances, latest version. Contractor shall obtain and pay for any permits required to perform this work from the City of Evanston. This work shall be paid for at the Contract unit price per EACH for ELECTRICAL GROUNDING OF WATER SERVICE."
