WHEEL TAX, RESIDENTIAL PERMIT, AND PARKING PASSES APPLICATION

This form is for applying for a wheel tax, residential parking permit, parking passes or current residents with new vehicles not yet registered with the City of Evanston.

The following documents are required to be submitted with the application:

- For Wheel Tax Current vehicle registration from the secretary of state.
- For Residential Parking Permit and Parking Passes must be eligible and submit proof of residency (See reverse side for list of accepted residency items)

Parking District Eligibility: In order to receive a parking permit and visitor parking passes, your vehicle must be registered to an eligible address within that district. To identify your residential parking district, please visit our website: www.cityofevanston.org/gis/311AboutMyPlace. Due to a recent revision and digitization of the parking districts some previously eligible addresses may not qualify for a parking permit.

Please note: All outstanding parking citations must be paid before obtaining a residential parking permit. Failure to do so may result in the delay of processing your application.

PROOF OF RESIDENCY

Proof of Residency within your Residential Parking District is required with all applications for both Residential Permits and Parking Passes. Acceptable documents include one of the following: 1) Current Illinois Driver's License 2) Current signed lease or real estate purchase agreement, or 3) a current utility bill (less than 30 days old).

TRANSFERS

If you replace a car at any time during the year, a transfer of your annual wheel tax can be done. A copy of the new vehicle registration and documentation showing that you no longer own the previous vehicle (trade, sale, donate) must be presented in person at the City Collector's Office, located on the first floor of the Morton Civic Center, 2100 Ridge Ave, or submit a 3-1-1 service request. The registered owner's information must be identical on both vehicles to be eligible for a transfer. A wheel tax transfer cannot be processed online.

ACCESS EVANSTON PROGRAM (One wheel tax only per household)

Income-eligible seniors and individuals with disabilities who are residents may be eligible for a 50% discount on one wheel tax per household. Residents must have been approved through the Access Evanston Program to qualify for a discounted wheel tax. Residents may apply for the Access Evanston Program at the City of Evanston Community Centers.
